NOTICE OF HSAP BYLAW AMENDMENTS

- (1) No Pro-Ration of Dues – Add the following sentence to Article III (Members), Section 3:
"HSAP dues shall not be pro-rated."

Section 3. Dues shall be payable in accordance with NAP bylaws. HSAP dues shall not be pro-rated.

Rationale – NAP dues are larger amounts than HSAP dues, and are pro-rated according to the NAP bylaws. In contrast, HSAP dues are only \$10 per year, and members have not expressed the need to have HSAP dues pro-rated. This amendment would clarify that HSAP dues are not pro-rated.

- (2) Allow Electronic Meetings for the Executive Board – Add the following new section 7 to Article VI (Executive Board): "Executive board members may participate in meetings by means of teleconference, videoconference, or any means of a communication technology by which all persons participating in the meeting can speak to and hear each other at the same time. Participation by such means shall constitute attendance at the meeting as long as such simultaneous communication is active and enabled."

Section 7. Executive board members may participate in meetings by means of teleconference, videoconference, or any means of a communication technology by which all persons participating in the meeting can speak to and hear each other at the same time. Participation by such means shall constitute attendance at the meeting as long as such simultaneous communication is active and enabled.

Rationale – The HSAP Executive Board is requesting from the membership the authorization to meet electronically. The Executive Board has invested in Adobe Connect to provide free educational modules to HSAP members, and could also use the utility to meet electronically if the need arises. Familiarity with Adobe Connect would assist the Executive Board in accomplishing the business of HSAP and helping to educate members in an easy and free manner.

- (3) Technical Proviso – Proviso: Authorize the HSAP Secretary to correct article and section designations, punctuation, and cross-references, and to make such other technical and conforming changes as may be necessary to reflect the intent of the association in connection with these bylaw amendments.

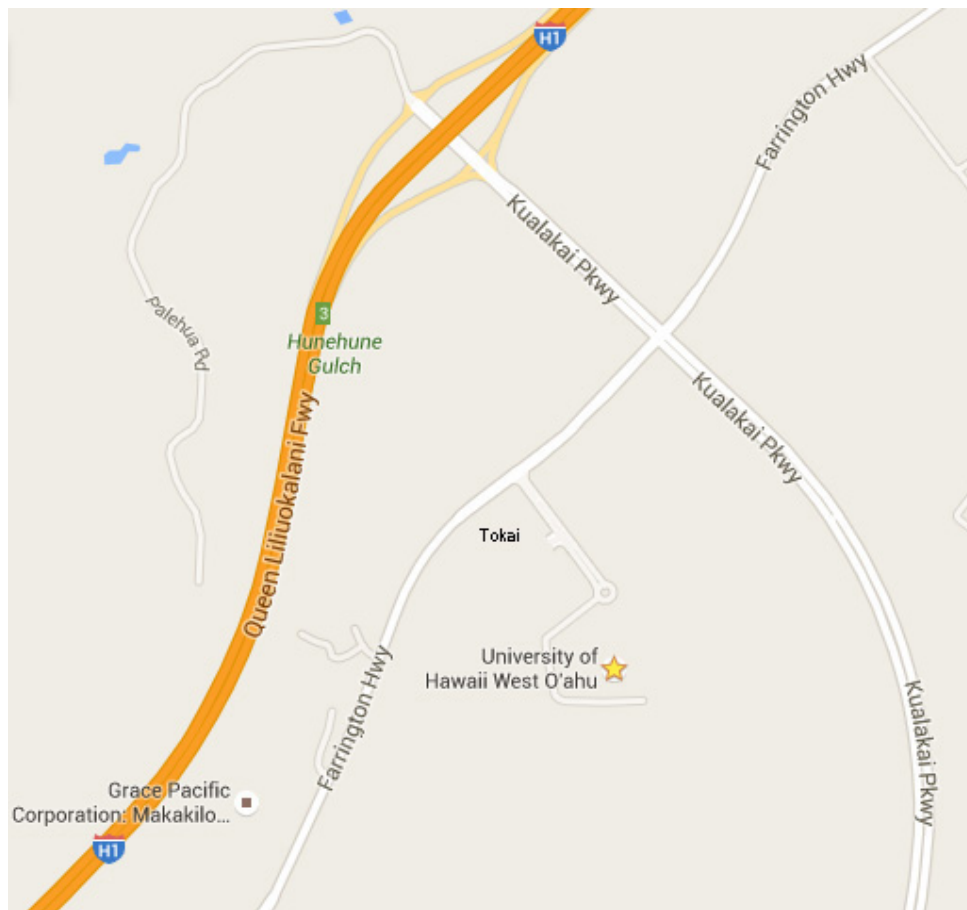

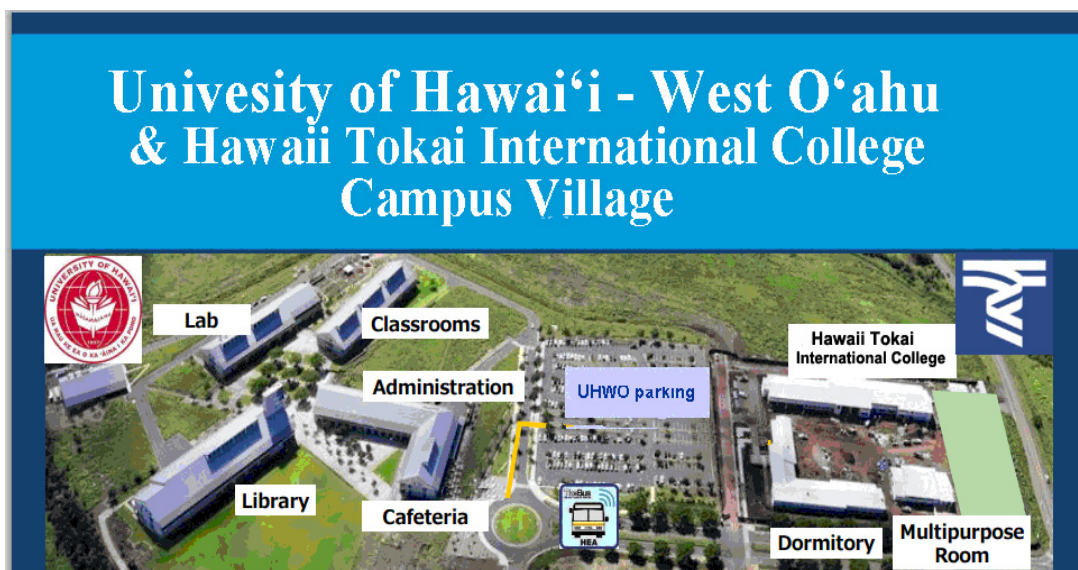
Please register early.
